Section C, clause 3.1.3 of Annex A of the Final Terms:

"**Coupon Barrier Event**" means, in respect of an Interest Valuation Date, the official closing price or level of the Underlying Asset on such Interest Valuation Date is ~~less than~~**greater than or equal to** the Coupon Barrier Level in respect of such Underlying Asset, as determined by the Calculation Agent.

In all other respects, the Final Terms is correct and all other terms and conditions of the Final Terms remain unchanged. Capitalised terms used but not defined herein shall have the same meaning ascribed thereto in the Final Terms.
