- (2) There was no share actually voted but excluded from calculating the poll results of the aforementioned resolutions.

As more than 50% of the votes were cast in favour of each of the aforementioned resolutions no. 1 to 4(C), the resolutions no. 1 to 4(C) were duly passed as ordinary resolutions of the Company. As a majority of not less than three-fourths of the votes were cast in favour of aforementioned resolution no. 5, the resolution no. 5 was duly passed as a special resolution of the Company.

As at the date of the AGM, the total number of Shares in issue was 1,410,964,391 Shares, which was the total number of Shares entitling the shareholders to attend and vote for or against the resolutions proposed at the AGM. There were no Shares entitling any shareholders to attend and abstain from voting in favour of the resolutions at the AGM pursuant to Rule 13.40 of the Listing Rules. No shareholders were required under the Listing Rules to abstain from voting on the resolutions at the AGM and none of the shareholders had stated their intention in the AGM Circular to vote against or to abstain from voting on the resolutions at the AGM.

The executive directors of the Company, Mr. LIU Chunhe, Mr. LI Ping, Mr. YE Chunjian and Mr. SU Jian and the independent non-executive directors of the Company, Mr. GAO Ming, Mr. CHI Shujin and Ms. CHEN Sichao attended the AGM.

Computershare Hong Kong Investor Services Limited, the share registrar of the Company in Hong Kong, was appointed as the scrutineer for the purpose of vote-taking at the AGM.
