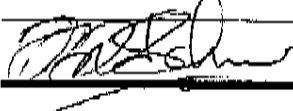

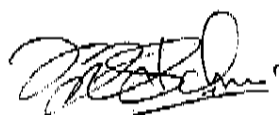
DIRECTIONS
