This base prospectus supplement (the "**Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with, the base prospectus dated 16 July 2020 as supplemented by the first base prospectus supplement dated 29 July 2020 (together, the "**Base Prospectus**") prepared by First Abu Dhabi Bank PJSC (the "**Issuer**", "**FAB**" or the "**Bank**") in connection with the Issuer's Euro Medium Term Note Programme (the "**Programme**") for the issuance of up to U.S.\$15,000,000,000 in aggregate nominal amount of notes (the "**Notes**"). Terms defined in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement.

This Supplement has been approved by the Financial Conduct Authority (the "**FCA**") in its capacity as competent authority under Regulation (EU) 2017/1129 (the "**Prospectus Regulation**").

This Supplement constitutes a supplementary prospectus for the purposes of Article 23 of the Prospectus Regulation and, together with the Base Prospectus, comprises a base prospectus for the purposes of the Prospectus Regulation. The FCA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or of the quality of the Notes that are the subject of the Base Prospectus. Investors should make their own assessment as to the suitability of investing in the Notes.

The purpose of this Supplement is to: (a) incorporate by reference into the Base Prospectus the unaudited consolidated financial statements of the Issuer as at and for the nine months ended 30 September 2020 and the independent auditors' review report thereon; and (b) update the no significant change statement in relation to the Issuer.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer, the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Accordingly, to the extent that there is any inconsistency between: (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement; and (b) any other statement in, or incorporated by reference into, the Base Prospectus, the statements in (a) above will prevail.

Save as disclosed in this Supplement, no other significant new factor, material mistake or material inaccuracy relating to the information included in the Base Prospectus which is capable of affecting the assessment of the Notes issued under the Programme has arisen or been noted, as the case may be, since publication of the Base Prospectus.

A copy of the Q3 2020 Financial Statements has been filed with the FCA and the Q3 2020 Financial Statements are incorporated by reference in, and form part of, this Supplement in their entirety and, by virtue of this Supplement, form part of the Base Prospectus.

Any non-incorporated parts of the Q3 2020 Financial Statements are either not relevant for an investor or are otherwise covered elsewhere in this Supplement or in the Base Prospectus.

No Significant Change Statement

The second paragraph under the sub-section headed "Significant/Material Change" on page 188 of the Base Prospectus shall be deemed to be replaced in its entirety with the following paragraph:

"Since 30 September 2020, there has not been any significant change in the financial performance or financial position of the Bank or the Bank and its Subsidiaries."
