Blue Square Announces Declaration of Dividend

ROSH HAAYIN, Israel, March 21, 2006 - Blue Square-Israel Ltd. (NYSE: BSI) (hereinafter: "Blue Square") announced today that its Board of Directors declared today a cash dividend of NIS 1.28 per share (the equivalent of approximately U.S. \$0.27 per share/ADS based on today's representative rate of exchange), aggregating approximately NIS 50 million (the equivalent of approximately U.S. \$10.7 million based on today's representative rate of exchange).

The dividend, net of taxes withheld at source pursuant to Israeli law, will be payable on or about April 20th, 2006 to shareholders of record as of close of business on April 3rd, 2006. The dividend will be paid to ADS holders a few days later. ADS holders will be paid in US dollars based on the representative rate of exchange of the US dollar against the NIS published by the Bank of Israel on or about April 20, 2006.

Blue Square further announced today that following the dividend distribution, the conversion ratio of our 5.9% convertible debentures issued in August 2003 (outstanding principal amount of NIS 185 million as of March 21st, 2006) will be adjusted on April 4th, 2006 due to the dividend described above. Following the adjustment, each NIS 31.606 par value of the convertible debentures will be convertible into one ordinary share of the Company.
