# 9 MONTHS TO 30 SEPTEMBER 2017

## **Consolidated revenue**

**Excluding Construction**, APRR's consolidated revenue totalled €1,851.1 million for the nine months to 30 September 2017, an increase of 3.9% from €1,781.9 million for the nine months to 30 September 2016.

Overall traffic measured by total vehicle kilometres travelled increased by 3.0% compared to the corresponding period to 30 September 2016.

Light vehicle traffic was up 2.7% compared to the corresponding period in 2016.

Heavy goods vehicle traffic was up 5.1% over the period.

The traffic was negatively impacted by calendar effects (2016 being a leap year), but benefited from the two new sections on the A75 at Clermont-Ferrand and on the A48/A480 in Grenoble.

**Excluding Construction**, APRR's consolidated revenue totalled €695.1 million in the 3<sup>rd</sup> quarter of 2017, an increase of 4.5% from €65.4 million in the third quarter of 2016.

Overall traffic measured by total vehicle kilometres travelled increased by 3.5% during the 3<sup>rd</sup> quarter of 2017 compared to the same period in 2016.

Light vehicle traffic was up 2.9% compared to the 3<sup>rd</sup> quarter of 2016.

Heavy goods vehicle traffic was up 7.1%.

#### Rating

On the 6 of October FitchRatings has upgraded APRR credit rating from BBB+ positive to A- stable.

APRR is also rated A- stable by Standard & Poor's since November 2016.
