**Notice of Change of Interests of Substantial Holder
Report on Acceptance Facility**

In accordance with Chapter 6C of the *Corporations Act 2001* (Cwth), BHP Billiton issues the attached ASIC Form 604 (Notice of Change of Interests of Substantial Holder) in relation to the ordinary shares in WMC Resources Ltd (**WMC Resources**).

BHP Billiton reports that since its most recent acceptance facility report on 3 June 2005, the aggregate of:

- the number of WMC Resources shares in respect of which acceptance instructions (in the form of acceptance forms and/or directions to custodians to accept BHP Billiton's offer) have been received in the Acceptance Facility as at 7:30pm on 3 June 2005 (as advised by Merrill Lynch Equities (Australia) Limited to BHP Billiton);
- the number of WMC Resources shares in which BHP Billiton has received as acceptances under its offer; and
- the number of WMC Resources shares acquired by BHP Billiton on-market,

has increased from 42.81% to 76.25%.

The following table is a breakdown of the aggregate amount between those three categories.

DIRECTIONS
