HWE Mining Pty Ltd awarded \$400 million contract extension at Yandi, WA.

BHP Billiton Iron Ore has awarded HWE Mining (now part of Leighton Contractors) a 2-year contract extension worth approximately \$400 million at Yandi, located in Western Australia's Pilbara region.
