Sub.: Reply - Clarification/Confirmation on news item appearing in Media/Publication

Dear Sir,

This has reference to your letter Ref No. NSE/CM/Surveillance/9279 dated 13.04.2020, forwarded by email dated 13.04.2020, we confirm the recent news appeared in the www.business-standard.com dated 12th April 2020 captioned "GAIL shuts Pata petrochemical plant on demand, offtake issue". The point wise clarifications of your queries are given below;

a) As a responsible corporate, the Company vide its letter dated 30.03.2020 (copy enclosed) filed with NSE/BSE, already informed that due to novel Coronavirus (COVID-19) outbreak across the globe and on account of country wide lockdown leading to force majeure situation, the Company has not been able to carry out its operational activities as usual as being carried out in the ordinary course of business.

Further, due to continuance of unprecedented lockdown, the Petrochemical Plant is under temporary shutdown w.e.f 3rd April 2020 due to lack of storage facility for finished products. The situation arose due to reduction of demand as well as transport restrictions in the country.

b) Further, the company informed earlier (through letter dated 30.03.2020) about the disruption in its operational activities to NSE/BSE. During temporary shutdown of Petrochemical Plant, the materiality aspects of this event was also examined. It was concluded that impact of such disruption is not a material information under the determining criteria for materiality of events and information as specified under clause (ii) of sub-regulation (4) of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in terms of GAIL's Board approved Policy for Determination of Materiality and Disclosure (also available at GAIL website). Hence, no specific disclosure was required to be made under the regulations.

c) In view of our reply at (b) above, the impact of the above event was not material and as such the above news item does not qualify to be a Material information requiring disclosure.

Hope the above clarifies the matter.

We wish to inform that in the wake of the novel Coronavirus (COVID-19) outbreak across the globe, Government of India, State Governments and Municipal Authorities have issued various advisories and directives. GAIL is coordinating all efforts to ensure on ground for implementation of the various measures against the spread of COVID-19.

The following steps were taken by GAIL to render its support to India' fight against Coronavirus:

1. To continue to render essential and emergent services and the operations of plants/offices with skeletal staff to ensure uninterrupted supply of Natural Gas including LPG, PNG, CNG and supply of products through processing of Natural Gas etc. to the extent possible.

3. The employees were asked to share the foreign travel history including family members/relatives.
4. Movement of GAIL employees to other work centers has been restricted.

On account of country wide lockdown leading to force majeure situation, the Company has not been able to fully carry out its operational activities as usual as being carried out in the ordinary course of business.

The Company is regularly following the directives issued by the respective Government authorities in this regard and will continue to closely monitor the situation and take appropriate action as per regulatory guidance.

Kindly take note of above events and put same on record. We will keep the Stock Exchanges informed with the developments taking place in this regard.
