

SPECIAL BUSINESS RESOLUTION - ANNUAL GENERAL MEETING

At the Annual General Meeting of the Petra Diamonds Limited (incorporated and registered in Bermuda under company registration number EC23123) (the "Company"), duly held and convened in the offices of Buchanan, 107 Cheapside, London EC2V 6DN on 23 November 2018 at 11.00 a.m., the following resolution was duly passed as resolution 13 as a special resolution:

Special Resolution

Disapplication of pre-emption rights

13.

- That, subject to the passing of resolution 12, the Directors be granted general power to allot Equity Securities (within the meaning of Bye-Law 2.5(g) of the Company's Bye-Laws) for cash pursuant to the authority granted by resolution 12 as if Bye-Law 2.5(a) of the Company's Bye-Laws did not apply to such allotment, provided that this power shall be limited to:
- (a) the allotment of Equity Securities in connection with a rights issue or an offer of Equity Securities, or an invitation in respect of the same, open for a period fixed by the Directors:
- i. to holders of ordinary shares in proportion (as nearly as may be practicable) to their respective holdings; and
- to holders of other Equity Securities as required by the rights of those securities
 or as the Directors otherwise consider necessary,

but subject to such exclusions or other arrangements as the Board may deem necessary or expedient in relation to treasury shares, fractional entitlements, record dates, legal or practical problems in or under the laws of any territory or the requirements of any egulatory body or stock exchange; and
