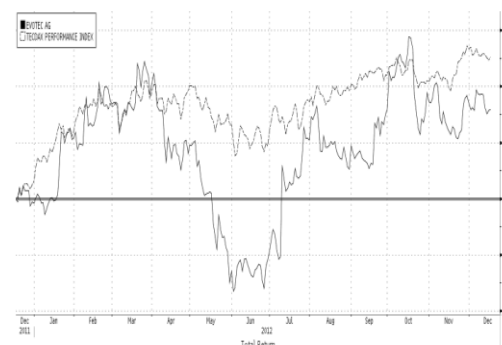

License agreement with Janssen

- Evotec announced an exclusive worldwide license agreement with Janssen regarding its NR2B subtype selective NMDA-antagonist portfolio for development against diseases in the field of depression. Evotec will receive an upfront payment of USD 2m, which should contribute to the top line in 4Q/12, and an additional USD 6m to be paid upon confirmation of certain pre-clinical properties of the candidates, which we expect to take place in 2H/13 (earliest 2Q/13). We expect to see more details regarding the indications after the second portion of upfront payment will be reached.
- Further financial terms of the agreement represent long-term potential and comprise: 1) Milestone payments up to USD 67m upon the successful completion of certain clinical, regulatory and launch events for a first product; 2) Reduced milestone payments upon successful completion of certain events for additional indications and/or compounds; 3) Additional USD 100m for commercial milestones depending and upon meeting certain sales thresholds and 4) Double-digit royalties on certain future sales of royalty bearing products.
- The compounds in the portfolio are orally active NR2B subtype selective NMDA-antagonists which were developed from discovery stages through to clinical studies by Evotec. In 2009 Roche entered into an agreement with Evotec for Phase II clinical development of the portfolio compounds in patients with treatment-resistant depression, which was terminated in 2011. After that termination there was a write down risk associated with this compounds portfolio. In our view, the agreement with Janssen has eliminated this risk.
- We believe that Evotec's share at its current level remains clearly undervalued. The agreement with Janssen as well as other deals, announced in November (partnership with Haplogen to develop drugs for infectious diseases and biology collaboration with Probiobdrug) have not been reflected in the share price, in our view.
- We leave PT at EUR 3.90 and confirm our BUY recommendation.
