Pixium Vision's bionic vision systems combine advanced medical technologies, bio-electronic and optical engineering and digital technologies to recover visual perception. Pixium Vision's bionic vision systems are associated with a minimally invasive surgical implantation followed by a training and readaptation period. Pixium Vision has developed PRIMA, a new generation sub-retinal miniaturized photovoltaic wireless implant system, for patients suffering atrophic dry age-related macular degeneration (dry AMD), a large unmet medical need, resulting in central vision loss for the elderly. PRIMA is in clinical trials in France and in the USA. Pixium Vision collaborates closely with academic and research partners spanning across the prestigious Vision research institutions including the Institut de la Vision in Paris, Stanford University in California, Moorfields Eye Hospital in London, and Institute of Ocular Microsurgery (IMO) in Barcelona. The company is EN ISO 13485 certified.
