

SINTANA ENERGY INC. COMPLETES SALE OF VMM-4 BLOCK INTEREST

TORONTO, ONTARIO – August 28, 2017 - Sintana Energy Inc. ("**Sintana**") (TSXV: SEI) is pleased to announce that it has completed the sale of its 15% participation interest in the VMM-4 Block in Colombia for US \$275,000. This successful sale is a major step in Sintana's ongoing initiative to monetize non-core assets. Proceeds will primarily be used for obtaining professional services associated with regulatory compliance requirements.

The VMM-37 Block in Colombia's Magdalena Basin remains Sintana's core asset. Hydraulic stimulation of the Manati Blanco-1 well, the initial well on this Block, is the prime focus of management's attention. Obtaining an environmental permit for this activity is the next major milestone in the exploration program for this 43,000 gross acres asset.
