
## Sonae Announcement

The voluntary public tender offer (the "Offer") period (the "Offer Period") for all Musti Group Plc ("Musti" or "Company") outstanding shares ("Shares") was extended until 15 February 2024.

Sonae SGPS SA ("Sonae") hereby informs that, following its announcements published on <u>29 November 2023</u><sup>1</sup> and <u>15 December 2023</u><sup>2</sup>, the Finnish Financial Supervisory Authority has today approved the first supplement³ (the "First Offer Supplement") to the tender offer document (the "Offer Document") submitted by Sonae subsidiary, Flybird Holding Oy (the "Offeror"), to its approval, subsequently to the offer price increase to EUR 26.10 per Share (previously EUR 26.00 per Share), announced by the Offeror on 25 January 2024³.

Consequently, the Offer Period initiated on 18 December 2023 and that was set to expire on 05 February 2024 was extended by the Offeror until 15 February 2024.
