Kingspan Group plc would like to notify the market of the following changes to the capital of the Company as at 30 April 2024:

Re-issue of Treasury Shares

The Company announces that 32,966 Ordinary Shares of €0.13 each were transferred out of the Company's holding of treasury shares pursuant to the exercise of options under the Kingspan Group Performance Share Plan. The shares were transferred at a weighted average price of €84.14 per share.

Issued Share Capital Update

The Company's issued share capital consists of 184,596,642 ordinary shares of €0.13 each. The Company now holds 1,407,840 ordinary shares in treasury. Therefore, the total number of voting rights in the Company is 183,188,802.

Confirmation of number of voting rights

The above figure 183,188,802 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest, or a change to their interest, in Kingspan Group plc under the Disclosure and Transparency Rules.
