Kingspan Group plc, the global leader in high-performance insulation, building envelope and advanced building systems solutions, announces that it is considering a potential IPO of ADVNSYS (previously its Advanced Building Systems segment).

ADVNSYS is a world leader in bespoke critical infrastructure primarily focused on data centres, ventilation, and daylighting. With its innovative product suite and global scale, ADVNSYS is uniquely positioned to deliver a growing proposition for global customers in the rapidly expanding AI and data centre market.

A prospective IPO has the potential to unlock meaningful value for Kingspan's shareholders in highly rated technology and data centre capital markets. It would give ADVNSYS a valuable sector profile in its own right, appealing to its customers and other stakeholders.

In any potential IPO structure, Kingspan will remain a strong majority shareholder of ADVNSYS and will continue to consolidate its revenues and earnings.
