Pursuant to the Article 474 paragraph 1 of the Capital Markets Act, Atlantic Grupa d.d., Zagreb, Miramarska 23 (hereinafter also as: the Company) informs that, pursuant to the Optional Award program and the awarding politics of Atlantic Grupa, with the purpose of its realization among its employees, that on 23 June 2025, it has transferred 1,674 of its own shares of the total nominal amount of EUR 13,392.00, which represent 0.01% of subscribed capital of the Company, to its employees. Before such transfer, the Company had 62,146 of its own shares, of the total nominal value of EUR 497,168.00 which represent 0.47% of subscribed capital of the Company. After the transfer the Company holds 60,472 of its own shares, with the total nominal value of EUR 483,776.00 which represent 0.45 % of subscribed capital of the Company.
