In accordance with the provisions of article 23 para (1) from the Articles of association of the National Power Grid Company Transelectrica SA, the Supervisory Board elects Mr Cătălin NITU as Directorate Chairman, alternatively called Executive Director General or Chief Executive Officer - CEO - of the Company for the National Power Grid Company Transelectrica SA.

The appointment of Directorate members mentioned above will become effective on the signing date before the notary public of the mandate acceptance statement as member in the Directorate of the National Power Grid Company Transelectrica SA, but not earlier than December 21, 2019.
