S.I.F. Oltenia S.A. informs shareholders and investors that in the **file no. 3607/63/2020** pending before Dolj Court, Civil Section II, against Forțan Procopie and Miulescu Mihai Răzvan as plaintiffs, S.I.F. Muntenia S.A., Cristian Bușu as interveners on behalf of another person, Szitas Ștefan – intervener in his own name, having as object action in absolute nullity of the S.I.F. Oltenia S.A. OGSM Decisions on 28.04.2020, chaired by the Vice president Cristian Bușu and finding the nullity of OGSM on 12.10.2020, the court rejects the exception of the lack of active procedural capacity of the plaintiff Miulescu Mihai. Rejects the request for finding the nullity of the GSM decisions on 12.10.2020. Dismisses the application for leave to intervene made by the intervener, Szitas Ștefan. Rejects without object the request for finding the nullity of the GSM decisions on 28.04.2020. Grants the application to intervene made by the interveners S.I.F. Banat Crișana S.A. and S.I.F. Muntenia S.A. With appeal.
