**S.I.F. Oltenia S.A.** informs investors that in the **file no.** 2636/63/2020 pending before Craiova Court of Appeal, Civil Section II as defendant, against S.I.F. Muntenia S.A., S.I.F. Banat Crişana S.A., SAI CERTINVEST S.A., for FIA CERTINVEST ACŢIUNI, FDI CERTINVEST BET FI INDEX and FDI CERTINVEST XT INDEX in the capacity of plaintiffs and interveners on their own behalf: Ivănescu Dumitru, Complex Doina S.A., Lin&Ema SRL by Buzdea Gheorghe Cătălin, Tudor Dumitru and Buzdea Gheorghe Cătălin having as object finding of document nullity - S.I.F. Oltenia S.A. OGSM Decisions no.1-8 on 28.04.2020, the court rejects the exception of inadmissibility of the appeal and the exception of lack of interest. Dismisses the appeal as unfounded. Obliges the appellant to the respondent plaintiff SIF MUNTENIA SA to pay the amount of 2000 lei, representing a reduced lawyer's fee. Definitive.
