Subject: Interim Management Statement

Nature of the Group activities

General overview of the financial situation and performance of the Group

During the reporting period, operating profits will be reduced compared to the same period last year. The reason for the reduction of the operating profits is due to the fact that some hotels in the Group have been opened later in the operating period due to renovations.
