Subject: Interim Management Statement

Nature of the Group activities

The principal activities of the Group is the ownership and management of hotel units in Paphos as well as the marketing and development of land.

General overview of the financial situation and performance of the Group

During the reporting period, operating profits will be reduced compared to the same period last year. The reason for the decrease in operating profits is due to the lower occupancy of the Group's hotels. The Group will show reduced profits as compared to the same period in the year 2018.

Developments and Prospects

The Board of Directors and the Management consider that under the present circumstances and taking into account the global economic situation, the results in the current year are expected to be better in relation with those of the year 2019.
