Taking control of all operational and business development responsibilities, an acquisition and further development of an (at the time) market-leading technology platform was undertaken. As part of a start-up, the technology was acquired for R400,000 in 2001. The technology was re-developed for an

investment of R12,5 million between 2001 to 2004, and the relevant business unit was sold to Tracker in 2005/2006 for ca R170 million, delivering a significant return to shareholders.
