On 11 December 2025, AIAG acquired 286,196 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 18.4372 per share, for a total consideration of approximately EUR 5,276,652.89. The transaction was executed on the Athens Stock Exchange and on private trading venues operated as Multilateral Trading Facilities (MTFs).
