On 17 December 2025, AIAG acquired 345,624 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 18.1304 per share, for a total consideration of approximately EUR 6,266,301.37. The transaction was executed on the Athens Stock Exchange and on private trading venues operated as Multilateral Trading Facilities (MTFs).
