# **Conversion of shares in Electrolux Professional**

**According to the articles of association of Electrolux Professional AB (publ), owners of Series A shares are entitled to request that such shares are converted to Series B shares. Conversion reduces the total number of votes in the company.**

During April 2025, 61 Series A shares were converted to Series B shares at the request of the shareholders, following which the total number of voting rights in the company amounts to 35,964,397.8.

The total number of registered shares in the company amount to 287,397,450 of which 8,027,392 are Series A and 279,370,058 are Series B.
