Change of number of shares and votes

The warrants programme for management, division management, other senior managers and key employees implemented at the Annual General Meeting on 6 May 2015 (Warrants Programme 2015/2019) has resulted in an increase of the number of shares and votes in the company during November 2018 with 1,786,800 shares of series B and as many votes, through conversion of subscription warrants into new shares in Hexagon AB.

As per 30 November 2018 there are in total 362,924,692 shares in the company, of which 15,750,000 are of series A with ten votes each and 347,174,692 are of series B with one vote each.

The total number of votes in Hexagon as per 30 November 2018 amounts to 504,674,692.
