Staffan Dahlström has worked for HMS since 1989 with development and manufacturing and has been responsible for Sales & Marketing since 1998. In that role he has built HMS' sales force with subsidiaries in Japan, China, Germany, the USA, France and Italy. He has been a member of the board since 1989.

Nicolas Hassbjer will be engaged as a non-executive director of HMS and other growth companies. In addition he will be available to support specific projects at HMS.

"Since I founded HMS in 1988 I have been committed as an entrepreneur to lead the company through the different growth phases. After 21 years as CEO it is time for a change and I look forward to a less executive role and spending some more time with my family. As a major shareholder and vice Chairman, I will have a continued commitment to HMS," he explains.

HMS Networks AB (publ) is a world-leading supplier of communication technology for industrial automation. Sales for 2008 totalled SEK 317 million. Over 90% of these sales were to customers located outside Sweden. All development and the major portion of manufacturing is carried out at the head office in Halmstad. Sales offices are located in Japan, China, Germany, the USA, Italy and France. HMS has 160 employees and produces network interface cards and products to interconnect different networks under the trademark Anybus®. The network interface cards are embedded in automation equipment such as inverter drives, robots, control systems and sensors. This allows subcomponents in machines to communicate with one another and with different networks in order to build more efficient and flexible automation systems with reduced energy consumption.

In 2008 HMS was presented with Sweden's "Best export company" award by the King of Sweden and HMS has had an average growth of 30% year-on-year over the past ten years. HMS is listed on the NASDAQ OMX Nordic Exchange in Stockholm in the Small Cap, Information Technology sector.
