## Repurchase of Truecaller B shares in week 31, 2024

**During 20 July 2024 and 2 August 2024 Truecaller AB (publ) (LEI code 549300TEYF1FA5G5GK26) has repurchased in total 215,000 own B shares (ISIN: SE0016787071) as part of the share buyback programme initiated by the board of directors.**

The share buybacks form part of the share buyback programme announced by Truecaller on 28 May 2024. The share buyback programme will run between 28 May up until the 2025 AGM which will be held in May 2025, and is carried out in accordance "Emittentregelverket".

On the Annual General Meeting 2024 the Board was authorized to buy back B-shares up until the Annual General Meeting in 2025. The new authorization means that buybacks may be made so that the company's shareholding does not exceed ten (10) percent of the total number of shares in the company outstanding as of the date of the annual general meeting.

**Following the above acquisitions. Truecaller's holding of own shares amounts to 1,557,832 B shares and 5,600,000 C-shares as of 2 August 2024, which corresponds to 2.17% of the outstanding capital.**

**The total number of shares in Truecaller, including own shares, now amounts to 353,040,414 and the number of outstanding shares, excluding own shares, amounts to 345,282,582.**
