

## Repurchases of shares during week 48, 2025

**Between 24 November and 28 November 2025 Attendo AB (LEI code 549300KEJDL2FNITUW65) ("Attendo") has repurchased in total 211,842 own shares (ISIN: SE0007666110) as part of the repurchase program initiated by the Board.**

The repurchases form part of the repurchase program of a total maximum amount of SEK 200,000,000 that Attendo announced on 24 October 2025. The repurchase program, which runs between 3 November 2025 and 4 February 2025, is being carried out in accordance with the Market Abuse Regulation (EU) No 596/2014 and the Commission Delegated Regulation (EU) No 2016/1052.

The total number of shares in Attendo, including the own shares, is 151,196,126 and the number of outstanding shares, excluding the own shares, is 146,645,119.
