

## **Change of Number of Shares and Votes in Karolinska Development**

**STOCKHOLM – June 29, 2018.** The number of series B shares in Karolinska Development AB (Nasdaq Stockholm: KDEV) has increased by 57 351 shares via allotment of shares to a participant in the share-based incentive program (PSP 2015) decided by the Annual General Meeting in 2015.
