

## KPN Broadcast Services deploys new solution for TV coverage of 18 top football stadiums based on Net Insight's Nimbra platform

The order from KPN Broadcast was placed through Net Insight's Dutch partner Alphatron Broadcast Electronics and the equipment will be delivered during the fourth quarter 2008.
