SinterCast appoints Remium as Liquidity Provider

The Liquidity Provider guarantees that, for a minimum of 85% of the trading time at the Nordic Exchange, the difference between the bid and ask prices for the SinterCast share will not be more than 3%.

In order to activate the Liquidity Provider service, Dr. Steve Dawson, President & CEO of SinterCast has transferred 1,000 SinterCast shares to Remium. This transfer will be formally reported as a change in Dr Dawson's holding from 25,000 shares to 24,000 shares, although he retains ownership of all 25,000 shares.
