

“On 10th of March 2025 Nordea commenced a share buy-back programme of up to EUR 250 million. The share buy-backs will be carried out in accordance with the authorisation granted to the Board by the 2024 Annual General Meeting.

The repurchase of own shares in public trading is executed in accordance with Regulation No. 596/2014 and the Commission Delegated Regulation (EU) 2016/1052.”
