

On December 16th 2025 Nordea commenced a share buy-back programme of up to EUR 500 million. The share buy-backs will be carried out in accordance with the authorisation granted by 2025 Annual General Meeting.

The repurchase of own shares in public trading is executed in accordance with Regulation No. 596/2014 and the Commission Delegated Regulation (EU) 2016/1052.”
