# Change in Pihlajalinna Plc's Management Team

Pihlajalinna is planning the renewal of its operating structure and a transition to an organisational structure based on business activities. The renewal of the operating structure would also lead to a change in Pihlajalinna's segment reporting. Going forward, the operating segments would be the company's two business segments: Public Services, and Private Clinic and Hospital Services.

Pihlajalinna Group has appointed Eetu Salunen, Licentiate of Medicine and Master of Philosophy, as the new Head of Business Operations of Public Services and member of the Group Management Team. Salunen will take up his position and become a member of the Management Team on 1 August 2022.

Helsinki-based Salunen (b. 1969) has previously worked, among others, as the CEO of the Päijät-Häme Joint Authority for Health and Wellbeing, the Director of Health Services of the City of Espoo, the Branch Manager and shareholder of Med Group Oy, and the Chief Physician and a shareholder of MedOne Oy. He has also worked as a consultant in the public sector and is a member of the Board of Directors of some healthcare companies.
