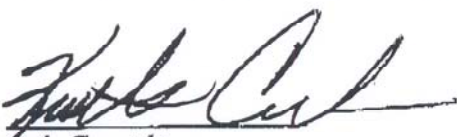
Enclosed herewith please find the information required by Section 29 of the Danish Securities Trading Act and Executive Order No. 728 of 11 July 2005.

1. The company making this notification is Julius Baer Investment Management LLC, 330 Madison Avenue, New York, NY 10017, United States (hereinafter "Julius Baer Investment Management").

3. The corporate name of the company whose shares are held is Royal Unibrew A/S. The company's nominal share capital is DKK 3,699,300,000, divided into 5,900,000 shares.
4. The 10% threshold was crossed by means of decrease in the total shares outstanding. As a consequence, the total number of shares held or deemed to be held by the shareholder is 609,336, which is equal to DKK 382,053,672 and 10.33% of the outstanding nominal share capital.

Julius Baer Investment Management makes decisions with respect to voting rights and purchase and sale of shares solely for reasons of investment on behalf of and in the name of clients, and has no intention of controlling the business or the management of the company in question. In addition, for each client account or portfolio having a separate investment policy, the investment decisions are made separately.
