

## Cleansing Notice under Section 708A(5)(e)

**MINNEAPOLIS, United States and BRISBANE, Australia July 31, 2026: Anteris Technologies Global Corp. (Anteris or the Company)** (NASDAQ: AVR, ASX: AVR) a global healthcare company committed to designing, developing, and commercializing cutting-edge medical devices to restore healthy heart function, announces that on July 29, 2026 US Eastern time (July 30, 2026 AEST), the Company issued 3,000 CHES Depositary Interests in the Company (**Shares**) to investors upon the conversion of 3,000 unlisted CDI warrants at A\$11.50 each raising A\$34,500.
