The financial statements of the period for 30 June 2003 were subjected to a limited review by Ernst & Young AG Wirtschaftsprüfungsgesellschaft with respect to individual questions and issues.

Business Development

As expected PSI improved its operative results (EBIT) by 71.6% compared to the first quarter and by 76% compared to the same quarter of the previous year. At –1.25 million Euro, the operative result of the first six months was within the projected range. The group result improved to –50,000 Euro in the second quarter and to –1.1 million Euro in the first six months. Sales went down in the first half-year by 14.8% to 65.84 million Euro. This was particularly due to the 42% decrease in hardware sales, the spin-off of PSI Infrastructure from the year before and licenses revenues, which decreased to 2.3 million Euro. The group's cash was 20.4 million Euro as of 30 June 2003.

The network management segment (energy, telecommunications, transport) had sales of 35.2 million Euro in the first half-year and an operative result of 1.6 million Euro. In the second quarter network management was strongly influenced by investment in the future MCCM technology for integrating GSM and UMTS mobile telecommunication standards.

In production management (production, logistics) sales dropped to 22.3 million Euro, while the operative result improved to –2.4 million Euro. This includes the development costs of the new manufacturing control systems. At the same time there was a positive impact from the improvement in PSIPENTA's earnings and the fact that the subsidiaries PSI logistics and PSI Switzerland broke even. New business processes were implemented to refinance PSIPENTA product innovations and will lead to further improvement in results.

Sales in information management (public sector, service providers) decreased to 8.4 million Euro in the first half-year and the operative result dropped to -0.5 million Euro. Political developments effecting unemployment and social welfare had a negative impact on PK Software orders. PSI Infrastruktur GmbH was not consolidated over the course of this year due to its merger with Schindler Technik AG.

At 64 million Euro, orders received in the first half-year were below the 68 million Euro of the previous year. This primarily was the result of the breakdown of a large energy contract into partial contracts. The energy segment currently has orders spanning far beyond a year. After a decrease in the months of April and May the number of incoming orders has again stabilized since June. The overall order backlog at the PSI group was 84 million Euro as of 30 June 2003.

Personnel Development

The number of employees in the PSI Group was reduced according to planning by 114 compared to the first half year of 2002 and by 52 since 31 December 2002 to 1,242.

Special Events in the 2nd Quarter

The PSI AG increased its share in the GSI mbH to 100%. The share in the PSI logistics GmbH was increased to 100%.

The structure of the group was further streamlined through the consolidation of the Internet subsidiary front2back with UBIS and the elimination of minority holdings.

Outlook

Investments made at the start of the year in optimizing working processes throughout the group were continued in the second quarter. Further administrative adjustments will be undertaken through the end of the year. In light of the measures implemented to improve cost structures, synergies between business units and the positive developments in the product management segment, the managing board of PSI foresees meeting the projected profit target with an annual revenue of at least 130 million Euro.

Notes on the consolidated financial statements as of 30 Juni 2003

The Company

1. Business Activities and Legal Background

The business activities of PSI AG relate to the development and sale of software systems and products fulfilling the specific needs and requirements of its customers, particularly in the following industries and services lines: utilities, manufacturing, telecommunications, software technology, Internet applications and business consulting.

The PSI Group is divided into the main business lines Network Management, Production Management and Information Management.

The Company is exposed to a number of risks that are similar to other companies active in the dynamic technology sector. Major risks for the development of the PSI Group are the successful marketing of its software systems and products, competition from larger companies, the ability to generate sufficient funding for future business development as well as individual risks regarding the integration of subsidiaries, organizational changes and the cooperation with strategic partners.

The Company was founded in 1969 and was converted from a limited liability company into a stock corporation in 1994. In 1998 the company went public on the Frankfurt Stock Exchange. The company has its headquarter in Berlin, where it has been registered at the commercial register, section B under the number HRB 51463. Main locations with business activities are located in Berlin, Aschaffenburg, Essen, Hamburg, Düsseldorf, Munich and Neviges.

2. Accounting and Valuation Principles

With regard to the principles of accounting and valuation and especially the differences between the German commercial regulations and the United States Generally Accepted Accounting Principles ('US-GAAP') see the group consolidated financial statement for the financial year 2002.

Allowances for bad debts are created when it is probable that the Company will be unable to collect all amounts due. The amount of the allowance for bad debts is based on management's best estimate of the expected future cash flows based on reasonable assumptions and projections.

Costs and estimated earnings in excess of billings on uncompleted contracts

Costs and estimated earnings in excess of billings on uncompleted contracts arise when revenues have been recorded but the amounts cannot be billed under the terms of the contracts. Such amounts are recoverable from customers upon various measures of performance, including achievement of certain milestones, completion of specified units or completion of the contract. Costs and estimated earnings contain directly allocable costs (labor cost and cost of services provided by third parties) as well as the appropriate portion of overheads including pro rata administrative expenses.
