- (a) The Company has issued 5,000,000 fully ordinary paid shares (**Shares**) in the Company at an issue price of \$0.0325 (3.25 cents) per Share from the exercise of 5,000,000 listed options (ASX Code: NVAO).
- (b) The Shares rank pari passu with existing Nova ordinary shares.
- (c) The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
