Ahlsell Danmark ApS announces extension of the offer period for its public offer for the shares in Sanistål A/S

Ahlsell Danmark ApS has decided to extend the offer period for its public offer for the shares held by ordinary shareholders in Sanistål A/S as regulatory approvals are still pending

Ahlsell Danmark ApS will extend the offer period until 22 December 2022 at 17:00 (CET)

In accordance with section 5.2 of the offer document dated 7 June 2022, Ahlsell Danmark ApS hereby announces its decision to extend the offer period until 22 December 2022 at 17:00 (CET). The decision is based on necessary regulatory approvals still being pending. Ahlsell Danmark ApS has agreed with Sanistål A/S and the Major Shareholders to postpone the deadline for fulfilment of the regulatory approvals-condition pursuant to the Transaction Agreement and the Share Purchase Agreements from 24 November 2022 to 23 December 2022. Accordingly, the Transaction Agreement and the Share Purchase Agreements will for now remain in effect until and inclusive of 23 December 2022. The prolonged date has been determined by the parties to allow for necessary regulatory approvals.

Through purchases made during the offer period, Ahlsell Danmark ApS as of 21 November 2022 owns 584,708 shares in Sanistål A/S and section 3.5 of the offer document shall be amended accordingly.

Ahlsell Danmark ApS has been informed that on a preliminary basis acceptances have been received for 1,541,086 shares, equal to 12.92%, which together with shares already acquired and shares to be acquired by the Share Purchase Agreements with the Major Shareholders, totals approximately 93.32% of the shares.

Thus, if the offer becomes unconditional and is completed Ahlsell Danmark ApS expects to be able to compulsory acquire any other shares in Sanistål A/S.

All other terms and conditions of the offer are unchanged. Shareholders who have already accepted the offer do not need to take any further action.

The extension of the offer period and the terms hereof are set out in supplement IV to the offer document which also includes a new acceptance form for ordinary shareholders.

Unless the offer period is extended again, Ahlsell Danmark ApS will announce the result of the offer no later than twenty-four (24) hours after expiry of the offer period.
