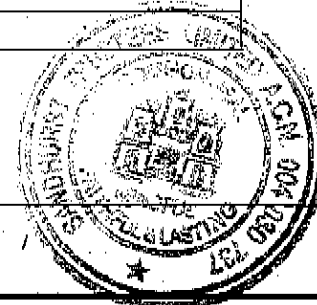

**DIRECTIONS**
