

POWER PRODUCTION 2018



- Full year power production estimate of 12,608 MWh, 5% less than 2017.
- Electricity sales revenue 2018 of EUR 4,157m, 1,3% less than in 2017.
- Average market price of electricity increased in 2018 to EUR 59,5 per MWh from EUR 48,6 per MWh in 2017.
- Average total sales price of electricity in 2018 was EUR 342,7 per MWh, an increase of 8% from 2017.



FY 2018 P&L



- Revenues higher due to higher electricity prices and one-offs
- First year with positive EBITDA since 2014.
- Costs of operations approximately EUR
 170k higher than "normal" due to thefts in South Italy.
- SG&A higher due to legal fees and taxes
- Full year gross litigation costs of EUR 2,7 million, approximately EUR 720k higher than budgeted.
- Net litigation costs of EUR 1,5 million after Therium contribution of EUR 1,1 million.
- Management costs lower than budget.
