Zürich, 28. februar 2022: Kongsberg Automotive (KA) har gjennomført salget av deres Interior Comfort System (ICS) enhet til Lear Corporation ('Lear') etter at salget ble [godkjent av den Europeiske Kommisjonen](#) fredag 25 februar, 2022.

ICS enheten leverer klimasystem for seter og komfort systemer til store bil- og seteprodusenter. Lear og KA inngikk en avtale om salget den 28. oktober 2021, og transaksjonen ble gjennomført 28. februar 2022 til en pris på EUR 175 millioner.
