5. 5. Share capital reduction by reduction of the nominal value of the shares

The following was approved:

- i. The share capital shall be reduced by NOK 97,210,962.30, from NOK 99,117,059.60 to NOK 1,906,097.30.
- ii. The capital reduction shall be carried out by reducing the nominal value per share by NOK 5.10, from NOK 5.20 to NOK 0.10.
- iii. The reduction amount shall be allocated to funds that may be used as resolved by the general meeting, pursuant to Section 12-1 (3) of the Norwegian Public Limited Liability Companies Act.
- iv. The share capital decrease is done with basis in the Company's annual accounts for 2024.
- v. The Company's Articles of Association Section 4 shall be amended to reflect the new share capital following the capital reduction.

- i. Aksjekapitalen nedsettes med NOK 97.210.962,30, fra NOK 99.117.059,60 til NOK 1.906.097,30.
