Pursuant to Section 4-3 of the Norwegian Securities Trading Act and the Securities Trading Act Regulations, we hereby disclose the following information.

On 30 November 2022, SMALLCAP World Fund, Inc. ("SCWF") acquired 270,921 shares of the Company, resulting in a shareholding amounting to 5.076% of total voting rights and 5.076% of total share capital. Please see the enclosed **Schedule A** for transaction details and **Schedule B** for the number of shares in the Company held by SCWF in respect of which this notification relates.

Please note that the notification submitted on behalf of The Capital Group Companies, Inc. as of 08 June 2021 included SCWF's holdings.
