Plaatsing aandelen Aalberts Industries tegen EUR 73,30 per aandeel; opbrengst EUR 55 miljoen

Aalberts Industries N.V., actief op de gebieden Industrial Services en Flow Control, heeft met succes 750.000 gewone aandelen geplaatst tegen een koers van EUR 73,30 per aandeel. De aandelen werden geplaatst bij institutionele beleggers en zijn volledig dividendgerechtigd over het boekjaar 2006 en volgende boekjaren. De onderneming heeft een bruto-opbrengst gerealiseerd van EUR 55 miljoen. ABN AMRO Rothschild trad op als "Sole Global Co-Ordinator en Bookrunner" van de transactie.

Betaling en levering van de nieuwe aandelen zullen naar verwachting plaatsvinden op 16 februari 2007, op welke datum verwacht wordt dat de nieuwe aandelen verhandelbaar zullen zijn en de notering zal plaatsvinden aan Euronext Amsterdam N.V.'s Eurolist by Euronext. Na sluiting van de plaatsing staan 25,3 miljoen gewone aandelen Aalberts Industries uit.
