Ingo Uytdehaage to become Adyen's co-CEO, Ethan Tandowsky to join its Management Board as CFO

Kamran Zaki will be stepping down from his role as COO during Adyen's 2023 Annual General Meeting after a high-impact career at Adyen. Kamran will remain an active part of the team until the summer and will help make the transfer of the role as smooth as possible. His responsibilities will be split between Ingo Uytdehaage, who will be running the Operations and Product parts of the role, while Roelant Prins (CCO) will be adding Account Management to his activities.

"It has been a great run. I am extremely proud of the culture, teams, and products we have built and know there is much more in store for Adyen," said Kamran Zaki, Adyen's current COO. "With almost a decade at Adyen in the rear-view mirror. While I will miss the thrill of building Adyen, it's now time for a change."

The appointments of Ingo and Ethan as co-CEO and CFO are subject to regulatory approval by the Dutch Central Bank, followed by approval from shareholders during Adyen's 2023 Annual General Meeting on May 11.
