As per the supplemental form 8 submitted on 22 August 2014 and 8 September 2014, all Hyder Directors who held Hyder Shares (and, in the case of Ivor Catto, his wife) previously agreed to sell their entire beneficial holdings in Hyder Shares to ARCADIS at 730 pence per share. These beneficial holdings totalled 283,137 Hyder Shares.

On 5 September 2014, ARCADIS N.V. acquired 215,851 Hyder Shares; on 13 October 2014, ARCADIS N.V. acquired 17,286 Hyder Shares; and on 14 October 2014, ARCADIS N.V. acquired the remaining 50,000 Hyder Shares, each pursuant to these agreements.

Accordingly, no further agreements to purchase Hyder Shares remain in force.
