## **Besi Announces Supervisory Board Nomination**

As a technology banker, Ms ElNaggar's expertise was in advising semiconductor and semiconductor capital equipment clients, including ARM, ASML and STMicroelectronics. Ms ElNaggar, a US and UK citizen, has a B.A. in Economics from the University of Chicago and an MBA from Stanford University Graduate School of Business. Ms ElNaggar replaces Mr Kin Wah Loh who will resign his Supervisory Board position at the next Annual General Meeting of Shareholders as announced previously.
